They will be recorded, processed and stored in electronic archives, in compliance with the appropriate technical and organizational measures pursuant to art. 32 of the GDPR.

4. Personal data storage duration - the data will be retained for the duration of the classroom seat booking and deleted 5 years after their collection. Where data are anonymized, they may be kept for a longer period of time in order to carry out comparative analyses, statistics and to verify the effectiveness of the service itself.

5. Mandatory and facultative nature of personal data provision and consequences of a possible data provision failure - The provision of data for the previous purposes is mandatory. It will not be possible to book a seat in the classroom and consequently to attend lectures in person without it. In addition, the necessary data to comply with the current Italian and European Union legislation must be provided.

6. Communication and disclosure of data - Your data may be communicated - which is to say that Your data can be disclosed to one or more specific subjects- by the writer from without the University of Brescia to implement all the necessary legal requirements and/ or the service you requested. In particular, your data may be communicated to those subjects who may access them by virtue of law provisions, regulations or European community legislation, within the limits and in the manner provided for by these rules.

7. Transfer of personal data abroad – The data you provide will be processed only in Italy. The data center services are located within the European Union.
