

RULES FOR THE ACCESS OF STUDENTS TO UNIVERSITY RESIDENCES

1. GENERAL RULES VALID FOR ALL STUDENTS

UNIVERSITÀ

DEGLI STUDI DI BRESCIA

According to the national provisions in force, with effect from 1st September 2021, all university students, in order to access the university spaces and therefore also the residences, must be in possession of and must exhibit the COVID 19 green pass certification.

The green COVID-19 certification attests one of the following conditions:

a) anti-COVID 19 vaccination occurred, at the end of the prescribed cycle, which meanshave taken the first dose or the 15-day single-dose vaccine or have completed the vaccination course (valid for 9 months);

b) healing from COVID-19 occurred, with simultaneous cessation of the prescribed isolation following SARS-CoV-2 infection (validity 6 months);

c) carrying out a rapid or molecular antigen test with negative results for the SARS-CoV-2 virus " (validity 48 hours);

The user is obliged to communicate any type of variation relating to the validity of their green pass.

For all students arriving from abroad it is necessary to consult the website of the ministry of health (official website: https://www.salute.gov.it/portale/nuovocoronavirus/dettaglioContenutiNuovoCoronavirus.jsp?lingua=italiano&id=54 11&area=nuovoCoronavirus&menu=vuoto) to check if it is mandatory to carry out a period of isolation upon arrival on Italian territory; in this regard, it is preferable for all users arriving from non-EU countries to spend the quarantine in structures outside the university residences: if this is not possible, guests are invited to send immediate communication to the email address <u>reception@unibs.it</u> to check the availability of accommodation where you can carry out the isolation inside the university residences.

2. SPECIFIC INSTRUCTIONS FOR INTERNATIONAL STUDENTS

International students may find themselves in one of the following situations:

- 1- Student without COVID 19 green certification and in possession of equivalent certification, in accordance with the provisions of the circular of the Ministry of Health of 30 July (See requirements below) *
- 2- Unvaccinated student: a swab test should be taken every 48 hours until the fifteenth day after the first dose ingejction. The Lombardy Region has launched a vaccination campaign for all foreign students, even those not yet enrolled in the National Health Service;
- 3- Student who has completed a vaccination cycle not approved by the EMA: it is necessary to take a swab every 48 hours, pending indications from the Ministry of Health on the time that must elapse to be able to receive the dose of a vaccine approved by the EMA.

* Case 1: equivalent certification

With regard to the acceptance of vaccine certifications, it is specified that vaccination certifications, in accordance with the provisions of EU Recommendation no. 2021/816 of 20 May 2021, must contain at least the following contents: - identification data of the owner (name, surname, date of birth);

- data relating to the vaccine (name and lot);
- date (s) of vaccine administration;
- identification data of the person who issued the certificate (State, Health Authority).

Vaccination certifications, in paper and / or digital format, must be drawn up in at least one of the following languages:

- Italian;
- English;
- French;
- Spanish.





If the certificate was not issued in one of the four languages indicated, it must be accompanied by a sworn translation (which means that the document is authenticated and made official by the specialist translator before a judicial official through the compilation and signing of an oath report by the translator himself).

The validity of vaccination certificates is the same as for the green COVID-19 certification (EU digital COVID certificate) issued by the Italian State.

For the above uses, the vaccines currently accepted in Italy and authorized by EMA are:

- Comirnaty (Pfizer-BioNtech);
- Spikevax (Moderna);
- Vaxzevria (AstraZeneca);
- Janssen (Johnson & Johnson)

The healing certifications must contain at least the following contents:

- identification data of the owner (name, surname, date of birth);

- information on the holder's previous SARS-CoV-2 infection following a positive test (date of first positive swab);
- identification data of the person who issued the certificate (State, Health Authority).

All certifications of healing, in paper and / or digital format, must be accompanied by a sworn translation.

The validity of the healing certificates is the same as for the COVID-19 green certification.

HOW TO REQUEST THE GREEN PASS IF YOU HAVE AN EQUIVALENT CERTIFICATION:

YOUR REQUEST WILL BE SENT BY ATS BRESCIA TO THE MINISTRY OF HEALTH WHICH WILL SEND THE CODE TO DOWNLOAD THE GREEN PASS: UNFORTUNATELY THE TIMING OF THE CODE SENDING IS UNKNOWN, SO WE SUGGEST YOU TO APPLY AS SOON AS POSSIBLE.

Cases 2 and 3: vaccine reservation

3.VACCINE BOOKING PROCEDURES (VALID FOR ALL

From Monday 16 August university students, including those belonging to other regions or foreigners, will be able to book the anti-Covid-19 vaccination through the platform <u>reservationvaccinicovid.regione.lombardia.it</u>.

To access the vaccination reservation, simply enter your code on the dedicated page **tax and health card number**and proceed with the booking.

If the platform does not allow direct access, it is necessary to make a pre-registration request from the portal using the "Request authorization" button to enter your data. Within 24/48 hours from the registration request it will be possible to access the platform and proceed with the vaccination booking.



4. INSTRUCTIONS FOR BOOKING THE VACCINE FOR STUDENTS NOT REGISTERED TO THE NATIONAL HEALTH SERVICE

Foreign students not enrolled in the national health service can also access the reservation by sending a request for membership. However, it is necessary to be in possession of the Italian tax code. Citizens residing abroad can request it from the Italian diplomatic-consular representation in the country of residence.

In Italy it must be requested from the nearest "Revenue Office" of the city in which you reside.

The complete list of Lombard offices can be found on the website <u>http://lombardia.agenziaentrate.it/</u>. To request it, you must bring your passport.

Once you have entered the booking procedure via the link provided in the previous paragraph, it is necessary to proceed as follows:
