

Regulations for the safe use of university residences.

Rectoral Decree n. 1026 dated 04/11/2022

Art. 1 - Regulatory sources and purposes

1. This regulation introduces, modifies and/or reiterates, for the prevention of SARS-CoV 2 contagion, suspensive and derogatory measures with respect to the provisions of the General Regulations of University Residences in order to preserve the health of guests.
2. The provisions contained in these Regulations apply to anyone who has access to the University Residences facilities.
3. Students from abroad are required to comply with the instructions on the website of the Ministry of Foreign Affairs and International Cooperation (www.esteri.it), according to the country of origin, in order to safeguard and protect the health of all those who occupy university residences.
4. For anything not expressly provided for in these regulations, please refer to the "Shared protocol for regulating measures to combat and contain the spread of the SARS-COV-2 virus in buildings and spaces pertaining to the University of Brescia" (Rev. 11 of 23 June 2022 and subsequent amendments), as well as the General Regulations of University Residences.

Art. 2 – Visits

1. The assignees can receive visits from h. 08:00 to h. 11pm, except as noted below.
2. To access the Residence, visitors must be identified and registered by the concierge service personnel, by showing an identity document and, if foreigners not belonging to the EU, also a copy of the residence permit. Where necessary, the concierge staff will ask for the recipient of the visit's consent.

Art. 3 - Use of rooms

1. In the rooms, daily cleaning and sanitation must be carried out by the users. The University, through external cleaning service, guarantees the weekly and periodic cleaning, with deadlines communicated to the guests.
2. Each student is advised to ventilate the rooms often by opening the windows several times a day, especially after receiving visits.

Art. 4 - Common spaces

1. In all common areas it is highly recommended to:
 - a) wear at least a surgical mask or FFP2 type respiratory protection devices;
 - b) maintain an adequate interpersonal distance;

- d) wash your hands often and/or use the appropriate sanitizers;
 - e) ensure frequent air exchange.
2. Parties, student assemblies and any other activity that could give rise to gatherings of a large number of people are not permitted.

Art. 5 - Kitchens

1. Where there are no crockery and kitchen accessories to be used, in rotation, you must personally arrange for the purchase and keep them separately from those of other users.
2. Personal equipment must be properly stored among your personal items in the assigned locker.
3. After each use, the hob, the kitchen sink and the table must be cleaned with suitable degreasing and antiseptic detergents.
4. During the presence in the kitchens and especially when washing and drying the dishes, it is mandatory to use gloves and a mask.
5. A space must be identified in the refrigerators for each student and open food cannot be stored, or in any case such as to not guarantee perfect airtightness.
6. Floors should be washed daily using a solution of water and sodium hypochlorite (bleach).
7. Each student must encourage the continuous exchange of air in the common areas such as the kitchen, if present, leaving the windows open as much as possible.

Art. 6 – Corridors

In the corridors it is highly recommended to wear a surgical mask or FFP2 type respiratory protection devices, as well as maintaining an adequate interpersonal distance.

Art. 7 – Self-service laundry

The use of washing machines is permitted in compliance with the following requirements:

- a) entry to the laundry rooms must be reduced to the minimum necessary, ensuring frequent ventilation of the rooms and rotation in use;
- b) the clothes and items to be washed must be transported in sealed bags;
- c) once you enter the room, you must empty the contents of the bag into the washing machine, trashing the used bag in the appropriate bin;
- d) once the washing cycle, and possibly the drying cycle, has finished, the washed garments must be collected in a new, clean bag.

Art. 8 - External pertinences

In external appurtenances: such as courts, courtyards, etc. gatherings must be avoided. In smoking areas, a minimum distance of 4 meters must be guaranteed between one ashtray and another.

Art. 9 - Recreation room

Gatherings must be avoided in recreation rooms and an adequate distance must be maintained. Use must be programmed with a specific calendar.

Art. 10 - Snack place

Access to refreshment points, drink and food distributors must be reduced to the minimum necessary by ensuring frequent ventilation of the premises, shifts in use, tight stop times within these spaces, always maintaining an adequate distance. Before and after using the vending machines, hand disinfection is mandatory using the appropriate hydroalcoholic solutions.

Art. 11 - Study room inside the residences

The use of the study rooms inside the residences must always take place in compliance with the safety measures. User access to the study rooms is permitted to up to full capacity and within the limit of available workstations. The use of a mask (preferably FFP2) is recommended. The user will take care to frequently sanitize their hands with the hydroalcoholic solutions present in the premises.

Art. 12 - Requirements for the use of lifts and freight elevators for the disabled

1. The use of lifts or goods lifts is limited to cases in which it is strictly indispensable: in these circumstances, use is permitted to only one user at a time.
2. The University guarantees the periodic sanitization of the internal and external surfaces of the lift systems, including the call buttons.

Art. 13 - Canteen service

Access to the canteen service takes place in compliance with the capacity and established shifts.

Article 14 - Refuse

The University guarantees compliance with the regulations on waste collection and disposal and gives precise instructions to users regarding the disposal of masks in accordance with national and territorial regulations. In the event of ascertained positivity, the waste is not subject to separate collection but marked (with the wording Covid) and disposed of in the container intended for separate collection.

Art. 15 - Management of a Symptomatic Person

1. In the event that a student present in the residences develops symptoms attributable to Covid-19, he must immediately notify the circumstance to:

- a) head of the UOC Inclusion, Participation and University Residences – Dr. Sara Zuanon;
- b) to the email address reception@unibs.it

2. In the event of a positive swab result, the user is required to notify the University by complying with the provisions of points a) and b) of paragraph 1. It is required to present a certificate of negative testing before the easing of isolation measures.

3. From the communication of positivity to Covid until the negativization of the guest, documented by swab, the possibility of access by third parties and by the cleaning service to the Rooms will be suspended.

Art. 16 - Sanctions

1. All assignees of University residence services are required to fully comply with the obligations and provisions indicated in this document.

2. Anyone who contravenes these provisions will be subject, according to the specific case, to the sanctions provided for by the General Regulations for Residences.
