## SCHOLARSHIPS RESERVED FOR UKRAINIAN STUDENTS IN POSSESSION OF INTERNATIONAL PROTECTION

As expected by the Resolution of the Academic Senate n.102/2023 and by the Resolution of the Board of Directors n.138/2023, the University of Brescia provides for the A.Y. 2023/2024 n.17 scholarships reserved for Ukrainian students in possession of international protection, even if temporary (in accordance with Articles 5 quarter and quinques of the Law n.28 dated 5 April 2022), distributed as below:

- n.5 annual scholarships of the amount of €5.750,00 each, for students attending First and Second Cycle courses, Foundation Year and single courses in the A.Y. 2023/2024. Beneficiaries of the scholarship admitted to the Foundation Year in the A.Y. 2023/2024 will be exempted from the payment of the subscription contribute;
- n.12 annual scholarships of the amount of €5.750,00 each, for students already attending First and Second Cycle courses who will renew the subscription in the A.Y. 2023/2024 and will have acquired at least 24 CFUs within the 10<sup>th</sup> August 2023 (recognitions of activities carried out in previous careers are excluded from the CFUs count) or that have obtained the final certification related to the Foundation Year in the A.Y. 2022/2023 following the achievement of the exams planned for the whole program and who will apply for the first year of a First or Single Cycle degree course in the A.Y. 2023/2024.

The applications' review, the definition of the criteria for the assignment of the scholarships above mentioned, as well as the ranking arrangement of the eligible students will be managed by a specific Commission.

It is possible to apply for the scholarship from 15<sup>th</sup> August 2023 to 1<sup>st</sup> October 2023, through the attached form to be sent within such deadline to the email address: <a href="mailto:internationalscholarship@unibs.it">internationalscholarship@unibs.it</a>

To the Ukrainian students requesting the international protection, even if temporary (in accordance with Articles 5 quarter and quinques of the Law n.28 dated 5 April 2022), enrolled in the A.Y. 2023/2024 in a First/Second Cycle degree course for which accommodation in the university residences are available, based on the reconnaissance made by the competent offices, the minimum tariff will be applied.
