

GUIDELINES TO FINANCE PHD SCHOLARSHIPS. XL Cycle, A.Y. 2024/2025

PhD scholarships funded by Public and Private Institutions

Public and/or Private Institutions interested in funding one or more PhD scholarships will send to the U.O.C. Dottorati (Administrative Office of PhD Programmes) **a Letter of Intent** (form annexed) with which they undertake to fund a scholarship and to execute the relative Agreement, drawn up according to the prearranged framework, before the publication of the call for competitive examination, A.Y. 2024/2025.

The letter of intent is not necessary in case that the counterpart financing the scholarship fills-in directly the Agreement.

Agreement Framework

1. The Agreement should be received by the University signed in two (2) original paper documents or in one (1) original document if signed through electronical digital signature (no scanned signature) as soon as possible and certainly within 10 days prior the deadline of Call for competitive examinations for admission to the PhD Programmes, academic year 2024/2025;

2. Private Institutions are required to draw up a bank or insurance guarantee in case they pay the scholarship in yearly instalments. This guarantee must be filed upon signing the Agreement, and no later than the publication date of the Call for Applications.

3. The drawing up of the above-mentioned guarantee is **not required for Public Research Institutions** / **Public Bodies or Universities.**

Pursuant to the Italian Ministerial Decree February 22nd, 2022 n. 247, the gross amount of the PhD scholarship is fixed at € 16,243.00.

Since 01/01/1999 such scholarships have been subject to the payment of INPS (Istituto Nazionale di Previdenza Sociale - Italian national Social Security Institute) contributions under the "gestione separate" (self-employed workers) scheme, according to art. 2, clause 26 of Law 335/95. Pursuant to Law 92/2012 art. 2 para. 57 as amended, the INPS rate is as follows*:



1) as of January 1^{st} , 2024, it is equal to 35,03%, of which 2/3 at the sponsor's charge and 1/3 at the beneficiary's charge

2) as of January 1^{st} , 2025, it will be equal to 35,03%, of which 2/3 at the sponsor's charge and 1/3 at the beneficiary's charge

3) as of January 1st, 2026, it will be equal to 35,03%, of which 2/3 at the sponsor's charge and 1/3 at the beneficiary's charge

4) as of January 1st, 2027, it will be equal to 35,03%, of which 2/3 at the sponsor's charge and 1/3 at the beneficiary's charge

- The PhD Programme may also include possible study abroad periods, for a maximum period of 12 months in the three-years period of PhD Programmes. For such periods, which cannot exceed half the duration of the PhD Programme, the total sum of the scholarship is increased by 50% (€ 10.018,68 for a maximum of 12 months), also subject to INPS contributions.

- The PhD Programme may also include possible study abroad periods, for a maximum period of **18** months in the three-years period of PhD Programmes for double-degree Agreements with foreign Universities or activated pursuant to Article 4, paragraph 2 of the University PhD Regulations, envisaging the 50% increase of the scholarship (€ 15.028,02 for a maximum of 18 months), also subject to INPS contributions.
