MINIMUM MERIT REQUIREMENTS TO BE CONSIDERED AN ATHLETE STUDENT

Merit requirements for the admission to the Dual Career programme:

Year of enrollment	Merit requirements
1°year of a Degree programme and Single Cycle Degree Programme	No requirements
1°year of Master's Degree	Graduating from the First Cycle degree with a score of at least 90/110
2°year of a course of study at any level	Minimum Number of CFUs earned between 11 August of the previous year and 10 August of the current year): -10 CFUs in case of full time enrolment - 5 CFUs in case of part-time enrolment
Years after the 2° of a course of study at any level	Minimum Number of CFUs earned between 11 August of the previous year and 10 August of the current year): -20 CFUs in case of full time enrolment -10 CFUs in case of part-time enrolment

Definition of: Athlete of Olympic, National and Federal Interest

Definition of PO Athlete: PO athletes are those who, regularly affiliated, have concrete possibilities to win an Olympic Podium in the next Olympics thanks to their good placement in international competitions (World and European competitions, Olympic Qualifications or Olympic Games).

Definition of Athlete of National interest: Athletes of National interest are those who, regularly affiliated, take part in National Teams, Sports Meetings, International Competitions, World Cups, European and World Championships (absolute and of category), in an olympic or non-olympic discipline that has been defined as competitive by the relevant FSN (this last recognized by CONI).

Definition of Athlete of Federal interest

"Federal" Athletes are those who, regularly affiliated, holders of italian title, have been part of the Italian teams in international competitions, sports meetings and national tests in an olympic or non olympic discipline, defined competitive by FSN (recognised by CONI) in the last three years.
