For both ordinary and extraordinary Guest Houses, the rate is quoted on the basis of the dates indicated in the reservation. In the event that the check-in dates do not coincide with what was initially requested and estimated, the applicable rate will be rechecked in relation to the total days of stay and therefore the Guest will be asked for a possible adjustment. If the accommodation has been kept reserved and then unoccupied for the period provided, the Administration has the right to request the payment of the entire amount due for the period of stay requested, as loss of profit for other missed reservations. It is not possible to recalculate the monthly amount due in favour of the Guest, following the issuance of the payment order.
