## CORSI DI LAUREA MAGISTRALE Studentships for foreign students Academic Year 2014/15

Università degli Studi di Brescia publishes a call for the academic years 2014/2015 and 2015/2016 assigning 5 studentships for foreign students, funded by MIUR for internationalization 2011-2020 and by Cariplo (Grant 2011-1426) .

### **Academic year 2014/2015**

The studentships of € 5.500,00/each, all-inclusive, for foreign students with the first level qualification achieved abroad, enrolled at the first year of a Master Course (*Corso di Laurea Magistrale*). The calls are published in English by the Università degli studi di Brescia.

Studentships are divided as following :

Communication technologis and multimedia	n. 2
Land and environmental engineering	n. 2
Management (curriculum International business)	n. 1

If the studentships are not assigned the amount is shared among those valide candidates, up until the closing of the shortlist.

Students who are going to compete for studentships must submit the following documents (in English or Italian) within 12.00 a.m. of 6<sup>th</sup> August 2014 at the office "Servizio Protocollo" of Università degli Studi di Brescia - Piazza del Mercato, 15 - 25121 Brescia, from Monday to Friday from 9.00 a.m. to 3.00 p.m. (date of post stamp) or by e-mail at [ammcentr@cert.unibs.it](mailto:ammcentr@cert.unibs.it) :

- application form; Skype address and copy of the passport;
- declaration compliant with art. 46 del DPR 28 dicembre 2000 n. 445 which certifies the university career. It must be written on plain paper and addressed to Chancellor of Università degli Studi di Brescia
- List of exams with marks, if it can be applied at the first level university course ( the list can be drafted in the mother tongue if it is written in English, French and Spanish).

Studentships will be awarded at the sole discretion of the Examination Board that will be appointed by Chancellor's decree.

The Examination Board will carry out an analytical evaluation of the documentation produced, taking into account the differences in evaluation systems adopted by the institutions or countries of origins.

The Examination Board reserves the right to request integration of documentation and to subjects applicants to an interview via Skype.

### **Re-assignment for academic year 2015- 2016**

The students, who are awarded a studentship in the academic year 2014/2015, will be reassigned at the same conditions, for the a. y. 2015/2016 if they obtain n. 33 credits (CFU) by the date 10/08/2015.

## **Payment of the studentship**

The studentships will be paid to the awarded students who are regularly enrolled at the first year of Master Course (*Laurea Magistrale*) . In the second year studentships will be paid by November 30<sup>th</sup> 2015. Students must pay University fees according to the economical ISEU status.

For those students who will be hosted at the University residences, the studentship will be reduced of € 2.311 to pay the housing costs, and of € 68,00 for the catering service (one free meal from Mondays to Fridays and a second meal is available at a reduced rate).

Studentships will be subject to withholding taxes and social deductions according to the current laws including the fiscal burden of the University.

The total gross costs, including the University administrative ones, will weigh on:

Academic Year 2015/16 – n. 5 studentships - MIUR funds for internationalization 2011-2020
